## PARENT/GUARDIAN DEVICE AGREEMENT AND RELEASE

1. I/We have read and understand the terms of the Procedures and Rules for the Acceptable Use of the Device and the Student Device Agreement and have discussed them with my/our child.
2. I/We consent to and understand that Dexter Community Schools staff may monitor my/our child's electronic communications, including e-mail and files that he/she downloads, as well as consent to allow my/our child to use the device and I/we assume the risks associated with my/our child's use of the device.
3. I/We have discussed the Dexter Community Schools Device Agreement with my child and will support the school district in guiding my child in using the device inside and outside of school as an educational tool.
4. I/We understand that I am responsible for monitoring and guiding my child's activity outside of the school day and will prevent the use of their personal email account(s) on the district device. I/We will ensure appropriate access to the Internet and use of the device (including, but not limited to, preventing food or drink near the device).
5. I/We understand that the replacement cost for the student Chromebook is \$250. Optional insurance is available for purchase through PaySchools for \$25 per Chromebook. This premium is good for one school year.
6. I/We understand that I, and or my student are financially responsible for damage to or the loss of the device, as well as for any costs incurred due to my student's use of the device if the optional insurance is not purchased.
7. I/We understand that if there is a claim for insurance coverage, there is a standard per-breakage deductible of \$25 for the first two claims. Students, who have insurance claims on their Chromebook more than two times during a school year, for their regular, loaner, or replacement Chromebook, will face higher per-breakage deductibles. The deductible for the third insurance claim, and any claims thereafter, will be \$50 per claim.
8. Chromebook chargers that are damaged or broken are not included in the insurance coverage and will be replaced at a cost of \$25 for each occurrence. If a charger tip breaks off inside the Chromebook and cannot be removed, there will be a \$25 replacement charger fee as well as the deductible fee, if applicable.
9. I/We understand that DCS Administration has the final say in determining insurance and repair situations.
10. The insurance provided applies to any Chromebook issued to your child by the Dexter Community School District, whether it is the originally issued Chromebook, a loaner, or a replacement. The deductible is the same, whether the machine is the original, a loaner, or a replacement.
11. I/We hereby agree to release, indemnify and hold harmless, in both my/our personal capacity, and as guardians of my/our child, the school district as well as its board members, teachers, employees, administrators and adult volunteers, from any claims arising out of my/our child's violation of, or conduct in consistent with, the school district's Acceptable Use Procedures and Rules and the Student Device Agreement, including, but not limited to, claims arising from materials my/our child may download or relationships he/she may establish with people online, whether such claims arise from Internet use through school accounts or personal accounts.

## STUDENT DEVICE AGREEMENT For Students Under Age 18

All Student users of district devices are required to sign this Student Device Agreement (the "Agreement") in order to receive authorization to use the device. Dexter Community Schools (the "School District") does not authorize any use of the device that is not conducted in strict compliance with this Agreement and the School District's Procedures and Rules for the Acceptable Use of technology devices. Your signature below indicates that you have read the terms and conditions of this Agreement and the School District's Procedures and Rules for the Acceptable Use of district devices carefully and understand their significance.

1. I have reviewed and will abide by the Procedures and Rules for the Acceptable Use of district devices at all times.
2. I will take good care of and am responsible for the appropriate use of my assigned district device, case and accessories.
3. I will keep my district device secure at all times.
4. I will not loan my district device to anyone.
5. I will bring my district device to school fully charged and ready for use each day.
6. I will not disassemble, repair, damage, hack or subvert the security of the district device.
7. I understand that I must leave the district device in the district issued case at all times and not place any stickers on it.
8. I will not have my district device out in bathrooms or locker rooms.
9. I agree to abide by all policies governing the use of my district device, both in school and outside of school.
10. I understand that my district device is subject to inspection by staff at any time and that it remains the property of Dexter Community Schools.
11. I understand that I am responsible for any damage to or loss of the district device.
12. I will file a report with the main office in the event of loss/theft/damage/equipment failure within one school day.
13. I will return the district device, case and cables in good working order as directed.
14. I consent to, and understand that, the School District may collect and examine the district device when a student is suspected of violating the School District's policies, rules and procedures.
15. I understand and agree that the School District assumes no responsibility for my use of the district device and I assume the risks associated with use of the district device, including, but not limited to, intentionally or unintentionally gaining access to information and communications that I find inappropriate, offensive, controversial, or otherwise objectionable.
16. I understand that violating the School District's Procedures and Rules for the Acceptable Use of the district device may result in having my use privileges of the School District's district device suspended or revoked, and that I may be further subject to disciplinary action, in accordance with the School District Student Code of Conduct, or other legal action.
